

## TANF Detailed Expenditure Form (ACF 196-SUP)

The Temporary Assistance for Needy Families (TANF) Detailed Expenditure Form (ACF-196 SUP) is a TANF financial report required by the federal Claims Resolution Act of 2010.

Pursuant to the Claims Resolution Act of 2010, each state must collect and report detailed disaggregated data otherwise reported by the state on the TANF Financial Report (ACF-196) line 6m (other) and lines 5d and 6l (authorized under prior law). This includes federal TANF expenditures and state expenditures.

This information must be reported for two time periods: March 1 to March 31, 2011, and April 1 to June 30, 2011.

Expenditure categories reported by Oregon on the August 31, 2011, ACF-196 (SUP) are:

ACF-196 SUP Line	Expenditures Category	Description
<b>1d</b>	Domestic Violence Services	Temporary Assistance for Domestic Violence Survivors (TA-DVS) provides payments, not to exceed \$1,200 in a 90-day period, for emergency services necessary to help victims of domestic violence become safe.
<b>1e</b>	Mental Health and Addiction Services	Addiction services are provided to both TANF and TANF at risk clients. These non-treatment services include Drug and Alcohol and other Addiction and Prevention Services.
<b>1i</b>	Early Childcare and Education (Pre-K)	Pre-Kindergarten education through the Oregon Department of Education provides state-funded Oregon Head Start PreKindergarten (OHS PreK) services for clients. Ten percent of enrollment is reserved for children with disabilities.
<b>1n</b>	TANF Program Expenses	Direct costs of providing TANF program services including the costs of staff providing the services and the direct administrative costs of providing the services.
<b>1o1</b>	Additional Expenditures: Housing	The Housing Stabilization Program is administered by Housing and Community Services. Homeless Assistance Services payments, not to exceed \$7,200, can be made to Community Action Agencies for case management services and assistance in housing costs.
<b>1o2</b>	Additional Expenditures: Family Support and Connections	Family Support and Connections is a child abuse prevention program serving primarily TANF eligible families. Services include front-end support and interventions to TANF or at risk families to provide supports that will reduce the likelihood of later entry into foster care.
<b>1o3</b>	Additional Expenditures: Refugee	Refugee Services are provided to TANF eligible families including refugees and asylees residing in Multnomah, Clackamas and Washington Counties and receiving social services through the Refugee Assistance program structure. The services provided include case management and employment and training services provided by local refugee agencies during the first eight months after arrival in the United States.

ACF-196 SUP Line	Expenditures Category	Description
2a	Child Welfare	Child Welfare programs include non-IV-E Foster Care, Adoption Assistance, in-home services, family treatment and support services, family resources and support, tribal child welfare, special contracts, case management and on-going family preservation services to support maintaining the child in their own home or a home of a relative, or reunification of the family in a timely manner. Eligibility is the same as that found in the State Emergency Assistance Plan that was in effect as of September 30, 1995.
