**RULE SUMMARY**

These rules implement the statutes that direct local government notification to the Department of Land Conservation and Development of proposed and adopted changes to comprehensive land use plans and land use regulations. The rules currently require hard-copy notification (that is, that notices be provided on paper); the proposed rule amendments will allow local governments to submit these notices electronically, such as via e-mail, without providing paper copies.

The Agency requests public comment on whether other options should be considered for achieving the rule's substantive goals while reducing negative economic impact of the rule on business.
