WHEREAS, the Oregon Mortuary and Cemetery Board (Board) issued a Notice of Proposed Disciplinary Action on April 11, 2008, against the Licensee in Case No. 07-1030A; and issued an Amended Notice of Proposed Disciplinary Action on April 15, 2008, against the Licensee in Case No. 07-1030A; and

WHEREAS, the Licensee has not requested a hearing to contest the matters set forth in the Amended Notice of Proposed Disciplinary Action in Case No. 07-1030A; and

WHEREAS, the Board and the Licensee are desirous of resolving and settling those matters set forth in the Amended Notice of Proposed Disciplinary Action in Case No. 07-1030A without further proceedings thereon and this Consent Order constitutes the entire agreement of the parties and is a final order of the Board; and

WHEREAS, the Licensee is aware of the right to a hearing with the assistance of counsel and the right to judicial review of the Board's decision in Case No. 07-1030A and hereby freely and voluntarily waives those rights; and

WHEREAS, the Licensee hereby acknowledges that Licensee has read, understands, and agrees to the terms of this Consent Order; and

WHEREAS, the Licensee agrees that the Board may enter the following order:

NOW THEREFORE IT IS HEREBY ORDERED:

1. Licensee shall pay to the Board a civil penalty in the amount of \$1,500.00 for violating OAR 830-030-0100(5), OAR 830-030-0090(1)(d), and ORS 692.180(1)(g).
2. This Consent Order shall become effective when signed by the Executive Director of the Board.
