The Oregon Mortuary and Cemetery Board (Board) issued a Notice of Proposed Disciplinary Action and Opportunity for Hearing (Notice) on July 21, 2011 in the above-referenced matter.

The Board and the Licensees are desirous of resolving and settling those matters regarding Case Nos. 09-1043A and 09-1043B without further proceedings thereon.

The Licensees are aware of the right to a hearing with the assistance of counsel and the right to judicial review of the Board's decision in Case Nos. 09-1043A and 09-1043B and hereby freely and voluntarily waives those rights.

The Licensees acknowledge that Licensees have read, understands, and agrees to the terms of this Consent Order and that this Consent Order constitutes the entire agreement of the parties and is a final order of the Board.

The parties therefore agree as follows:

1. The parties stipulate to the findings of fact as set forth in the Notice, and incorporated herein by reference.
2. The parties stipulate that the conduct of Licensees A and B as set forth in the Notice was in violation of OAR 830-040-0000(6), OAR 830-040-0000(7), OAR 830-040-0000(8) and ORS 97.150 and grounds for discipline under ORS 692.180(1).
3. Licensee A and Licensee B each hereby acknowledge that it has read, understands, and agrees to the terms of this Consent Order and Licensees acknowledge that this Consent Order is a public document.
4. Licensees A and B agree that the Board may enter the following order, which shall be effective on the date it is signed by the Board:

ORDER

NOW THEREFORE IT IS ORDERED:

1. Licensees A and B shall pay to the Board civil penalties in the amount of two thousand dollars (\$2,000). Licensees A and B are jointly and severally liable for payment of civil penalties assessed under this Order; and

2. Licensees A and B are hereby reprimanded.
