AGENCY VS. ASSOCIATION

It has been almost a year since I had the pleasure of joining the Oregon Board of Massage Therapists as the Executive Director. This year has been a little crazy with many challenging moments and tremendous opportunities for growth. That said, it has been a wonderful year and I hope that you are pleased with the work the board is doing on behalf of massage in Oregon.



Over this past year I have had the great pleasure of speaking with many of the Oregon LMT's and candidates. During these conversations, questions about Insurance Billing, CPT Codes and Liability Insurance were frequently addressed. As a result, I realized that many therapists in Oregon are unclear when it comes to the roles played by the Oregon Board of Massage Therapists and the Professional Associations such as ABMP, AMMA, AMTA, IMA, OMTA and USMMA, to name a few. Therefore, I hope the following information summarizing the differences between our organizations and provides a clear direction so your questions can be answered accurately and efficiently.

The OBMT (Oregon Board of Massage Therapists) is a state licensing and regulatory agency. As such the OBMT's primary responsibility is to protect the public. This is accomplished by establishing and regulating the minimum standards for massage, maintaining a model curriculum to assure standards are taught, testing candidates to verify their knowledge and skills meet the requirements, establishing continuing education requirements, answering questions pertaining to licensing, statutes and rules, responding to complaints, conducting investigations, issuing civil penalties, etcetera.

Professional associations on the other hand are member driven. Their primary role is to support their members and advance the profession. There are several professional associations and each functions differently. Professional associations may offer liability insurance, industry periodicals, continuing education, networking opportunities, legal assistance, political lobbying, state and/or national conferences, resources to address questions regarding your practice (insurance billing, marketing, cpt codes, accounting, etc.) and more.

ON THE ROAD AGAIN!



Legislative Update



The Oregon State Legislative sessions are always full of surprises and this year is no exception. The OBMT is watching several bills this session and would like to share a few of the highlights;

- SB97 is a bill sponsored by the OBMT which would allow the renewal cycle to be adjusted by rule. This bill has passed the Senate and has had its hearing in the House committee. It has not had a work session and we are hoping it will be scheduled soon.
- SB405 is a bill sponsored by several semi-independent state agencies including the OBMT. This bill would allow semi-independent state agencies to enter into borrowing agreements. SB405 has passed the House and is currently awaiting a hearing in the Senate Audits committee.
- HB2029 is a bill sponsored by the Joint Legislative Audit Committee which will shift the agencies reporting requirements to off session years. This bill has passed the House and is scheduled for hearing and possible work session in the Senate Rules committee.
- HB2105 is a Cosmetology Board bill that redefines the Facial Technologists scope of practice and changes their title to Esthetician. While the OBMT agrees that full body skin care regulation is important there are several issues of concern with this bill. We encourage you to read HB2105 A-Engrossed which you can find on www.leg.state.or.us and contact the committee or your local Representative or Senator with comments.

Rules Hearing June 23, 2004 at 9:00 am



On the morning of June 23rd, the Oregon Board of Massage Therapists will be holding a hearing to consider testimony on rules changes to OAR 334-001-0012 and 334-001-0045. The proposed changes to OAR 334-001-0012 will amend the current 2003-2005 Biennium budget and adopt the budget for the 2005-2007 Biennium. The proposed changes to OAR 334-001-0012 will be the adoption of the OBMT's own personnel policy. Interested parties may appear in person to testify at this hearing. We ask that all parties interested in testifying present a written copy of their testimony at that time. Interested parties who are unable to testify in person may submit written testimony. Written testimony must be received prior to the close of the Hearing in order to be taken into consideration. The board meeting will commence immediately following the Rules hearing. The Board will vote on the rules changes at that time. Over the past year the Education Committee and the OBMT have worked diligently to incorporate the feedback received in regards to the changes that were made to CE a year ago January. With great teamwork and compassion the Education Committee returned to the OBMT with an alternate approach to the CE provider credentialing and reporting. This approach was supported unanimously by the OBMT and went to a hearing late last year. As a result the streamlined rules for CE were adopted effective January 1, 2005. The form you will find on the opposing page is a required document that must be included with your CE submission at the time of renewal. This form is a living document and, as such, may be subject to change. This form is available on our website. Please refer to the website for the most current version of this form prior to completing CE hours. We are committed to only making necessary changes and to honoring the form that was in place at the time the CE hours were completed. An open Letter of Invitation to submit Examiner statement of interest....

Our current exam pool is filled through the end of July 2005. We are now looking for examiners for August 2005 through January 2006.

The basics:

- To be considered you must be a LMT, licensed for a minimum of one year.
- Individuals who teach or are in any way affiliated with a massage school or program are not eligible for consideration.
- The contract rate is \$13.00 per hour.
- Interested parties must hold a current examiner contact with the Board of Massage Therapists prior to proctoring exams. For contract information please contact Shel Sherman @ 503-365-8657 x 2.
- All contract examiners must provide proof of having attended an OBMT Examiner Training session within the past 24 months. The OBMT offers training sessions free of charge to interested individuals on the dates listed below from 2 PM to 4 PM. You must contact Diana Nott @ 503-365-8657 x 1 in advance or mark your preference below to reserve your space in the training.
- Interested parties must be willing to proctor a minimum of 2 days.
- You must be willing and able to meet all contractual requirements.
- The deadline for submitting a bid to proctor for this next period is June 6, 2005. Eligible bids will be considered on a first come first served basis.
- The board of massage will accept one CE for each full day of examining.

If you are interested in proctoring the OBMT practical exam between August 2005 and January 2006 you must complete and submit the following statement of interest. Statements of Interest received after June 6th will only be considered on an as needed basis.
