Review Minutes:

Tim Deboodt called the meeting to order and asked Committee members to review the October 3, 2013 meeting minutes. There being no changes, **a motion to approve the October 3, 2013 minutes was made by Ken Fahlgren and seconded by Casey Kump. VOTE: FOR – UNANIMOUS.**

Public Comment:

No public comment given. **Tim Deboodt closed the public comment period.**

Old Business:

At the October 3, 2013 meeting, the Committee requested photos and/or additional information in reviewing classification for T15S, R22E Sections 19 and 20; and, T15S, R23E Sections 22 and 36. Photographs were provided to Committee members for further review.

After reviewing the photos, the Committee reached consensus on T15S, R22E Sections 19 and 20; and, T15S, R23E Sections 22 and 36 as presented by the Oregon Department of Forestry (“ODF”).

New Business:

At the October 3, 2013 meeting, it was proposed that the Committee consider conducting two meetings per month, rather than just one per month, in order to complete the preliminary classification review and map products by the target date of March, 2014. The Committee members agreed to continue the regularly scheduled meetings on the first Thursday of every month, and to add an additional meeting per month through March 2014, typically the fourth Monday of every month. A determination will be made after March 2014 as to whether to continue with two meetings per month. The proposed dates for the additional meetings are: December 16, 2013, January 27, 2014, February 24, 2014 and March 24, 2014. These supplemental meetings will be held from 1:30 p.m. to 3:30 p.m. at the COCC Open Campus, if available.

Continuing their edits of the Crook County lands, the Committee started with Township 16S (“T16S”), Range 16E (“R16E”) Section 1.
