Minimum Requirements for an ODOT-Approved Blasting Consultant

This document is to be used to evaluate a potential Blasting Consultant that is not already on the Oregon Department of Transportation Approved list. A Blasting Consultant is required for a project when **Section 00335.44 Blasting Consultant** is placed in the Special Provisions.

Resume Submittal

The Consultant cannot be an employee of the project Contractor or his subcontractors, explosives manufacturer, or explosives distributor.

The Consultant must be able to demonstrate involvement with at least 15 road construction projects that required blasting. At least 10 of the projects listed must have been road cuts where an existing road was adjacent (different than cuts for new alignments or within quarries). All of the listed projects must have been performed in the last 15 years.

The Consultant must have at least 10 years of experience in construction blasting within 50 feet of utilities, residential or commercial structures, or transportation facilities.

The Consultants resume shall include a list of blasting projects, including reference contact name and phone number, a description of the blasting work on the project, details of the blast plans, and modifications made during the project. The list of projects shall demonstrate a working knowledge of controlled blasting techniques, FHWA rock blasting guidelines, blast plan design, flyrock control, vibration and noise monitoring and control methods.
