

**APPLICANT BRIEFING FLYER  
FEMA-1956-DR-OREGON  
Severe Storms, Flooding, Mudslides, Landslides, and Debris Flows  
Declared February 17, 2011**

**WHAT:**

Federal funding is available to state and eligible local governments and certain private nonprofit organizations on a 75% Federal, 25% Non-Federal cost-sharing basis for emergency work and the repair or replacement of public facilities damaged by the severe storms, flooding, mudslides, landslides and debris flows that occurred in Oregon between January 13, 2011 and January 21, 2011.

This Applicant Briefing is the first step towards receiving assistance. At this briefing Oregon Emergency Management (OEM) staff will give an overview of the Public Assistance Program and the Hazard Mitigation Grant Program.

At this briefing the Request for Public Assistance (RPA) form will be distributed. The RPA form is the official application for federal assistance; this request must be submitted to OEM within 30 days of the designation (declaration) of your County.

**WHO:**

Those individuals responsible for restoring and operating infrastructure systems that provide local services to the public (government agencies, special districts, certain private nonprofit organizations) in the counties of Clackamas, Clatsop, Tillamook, Lincoln, Crook, and Douglas. The agent, financial officer, or an appointee who will actually be using the information should attend this briefing.
