Oswald West Award Presentation

The Oregon Board of Accountancy is pleased to name **Cathy Pollino, Oregon State Auditor**, as the first recipient of the Oswald West Award for her commitment to standards of excellence in governmental auditing on both state and national levels.

During 15 years of state service as a staff auditor for the Oregon Division of Audits, and more recently as Oregon State Auditor, Ms Pollino has been an advocate and active participant in advancing public accountancy on both state and national levels. Even though she is not herself a certified public accountant, Ms Pollino consistently demonstrates support for the profession by providing professional development and certification opportunities to her audit staff.

On a wider scale Ms Pollino participates in local, regional and national organizations that actively advocate for and set the standards for licensed public accountants in public service. She has served as Chair for both the Pacific Northwest Intergovernmental Audit forum and the Peer Review Committee for the National State Auditors Association. Ms Pollino was appointed Co-chair of the National Association of State Auditors, Comptrollers, and Treasurers Subcommittee for Faster Comprehensive Annual Financial Reporting.

The award will be presented to Ms Pollino at 4:00 p.m. August 22, 2005 at the Board office. Members of the public are welcome to attend this event.

Release of Exam Score Notices

During the first year of computer-based testing, examination scores were released by the AICPA to NASBA section-by-section over a 2-3 week period, beginning about two weeks after the closing of a testing window. Scores were reported to candidates during the first month of the testing window following the one in which they tested.

Beginning with the July/August 2005 testing window, some candidates will receive scores earlier than previous procedures allowed. Which candidates and how many will receive their scores earlier will depend on examination volume, the test content they were administered, the distribution of examinees within the testing window, and other factors.

Please be aware that candidates who test on the same day may receive scores at different times due to differences in required quality control procedures.

DISCIPLINARY ACTIONS

This is a brief description of action taken by the Board for violations of ORS Chapter 673 and OAR Chapter 801. This report is condensed and may not include all the facts set forth in the Board order. Readers should contact the Board for further information.

Brooks Peacock was assessed a \$1,000 civil penalty for holding out as a CPA in violation of ORS 673.320(3).

Melanie Correa Permit # 7549, was assessed a \$1,000 civil penalty for requested records in violation of OAR 801-030-0015(2)(b).

The disciplinary action described in the June, 2005 Newsletter for Gwendolyn Hanavan, permit #3812 was incorrect. The Newsletter stated violation of OAR 801-030-0020(1) professional misconduct and the correct violation is OAR 801-030-0010(1) professional competency.
