PORTLAND, OR—Prevailing wage experts with the Bureau of Labor and Industries (BOLI) will offer free seminars that provide contractors and public agencies an overview of Oregon’s prevailing wage rate law and how to identify and avoid potential problems.

The first seminars will be held in **Pendleton** on Wednesday, **Oct. 15th**. BOLI staffers have organized additional sessions for **Klamath Falls** on **Nov. 5th** and **Albany** on **Dec. 9th**. Each three hour session will provide time for questions.
