In 2013, Oregon led the nation in nonmedical use of prescription opioids, and opioid overdose deaths in the state have increased five-fold since 2000. In response, a Governor's Prescription Drug Task Force and multiple clinician and community groups have been convened to develop strategies and implement interventions to reduce opioid misuse, decrease overdose deaths and provide alternative pain management approaches. This session will review the Governor's Task Force report; discuss statewide strategies to address opioid misuse; and hear from public health and community clinicians who are actively implementing innovative approaches to address this urgent public health issue.
