<p>HSD Updates:</p>	<p>Chris Norman-</p> <ul style="list-style-type: none"> ▪ Marketing Education Outreach- feedback on dental benefit changes. Use as a template letter as it is easier to communicate on one page. Send out to the members affected. Version 2 to go out soon. Feedback is accepted and then will be presented at MEOC and DCO meetings; ▪ Redeterminations- There will be a separate webinar in May. All questions will be added to an FAQ. For March 2016, there were approximately 70,000 letters sent. With a 10 day closure. Over 23,000 were able to update and did not close. Approximately 43,000 additional letters sent yesterday (1/20/16); ▪ Testing ONE web portal and training 80 assistors per week. Soon the portal will able to be turned on for members. <p>Sarah Wetherson-</p> <ul style="list-style-type: none"> ▪ Rules process- there are three rules out currently: 1) pregnant women access is nearing completion 2) partial restoration of benefits 3) code D15-54 is completed.
