## Less than 90 days until the replacement MMIS goes live!

The Department of Human Services (DHS) is on track to implement the replacement MMIS in September 2008. This means DHS has less than 90 days to make sure all current DHS trading partners (TPs) can exchange all their registered electronic data interchange (EDI) transactions in the replacement system. This includes:

- **All current EDI transactions:** The 837P, 837I, and 837D (Claims); 835 (Remittance Advice); 270/271 (Eligibility); 276/277 (claims status), and managed care transactions, including the NCPDP 1.1. format; and
- **New EDI transactions** that will be available in September 2008: The 278 (Prior Authorization) and Pharmacy Point of Sale.

## Registration and testing activity for current system will end June 30, 2008

So that DHS EDI Support Services and the replacement MMIS contractor, Electronic Data Systems (EDS) can focus on testing in the replacement system, registration and testing activity in the current system will end June 30, 2008.

This means that on and after July 1:

- **DHS will not register or test new TPs until September 2008:** DHS will review all new Trading Partner Agreements (TPA). If new TPs are approved for testing, DHS will only process and test transactions for new TPs once the replacement MMIS goes live.
- **DHS will register and test changes for current TPs** until three weeks before the replacement MMIS goes live. If you are a current TP and want to register and test for additional transactions or change submitter information, send DHS your completed Exhibit C as soon as possible.

## EDI testing for replacement MMIS will begin in July 2008

DHS will distribute the EDI testing schedule in late June. Remember that you cannot start testing in the replacement system until you successfully log onto the new MMIS testing server.

- In order to begin testing EDI transactions in July, all current TPs must make sure they can connect to the new server first.
