OLCC Commissioners issue sanctions for liquor law violations and appoint Distillery liquor agent

PORTLAND, Ore. – At their monthly meeting on January 13, the Commissioners of the Oregon Liquor Control Commission ratified the following stipulated settlements:

D48 Bistro, 4725 SE Division Street, Portland; will pay a fine of \$2,805 or serve a 17-day liquor license suspension for two violations. The first violation was for permitting the Managing Member to mix, sell, or serve alcoholic beverages, or supervise those who do, without a valid service permit. The second violation was for permitting multiple patrons to take open containers of alcoholic beverages from the licensed premises. Licensee is Division Live Work, LLC, Stefan Kovatchev, member.

Tienda San Juan, 542 4th Street, Gervais; will pay a fine of \$3,795 or serve a 23-day liquor license suspension for failing to have someone on the licensed premises who could communicate effectively with customers and Commission regulatory employees during business hours. Licensee is Catarino Olvera.

For an employee(s) failing to verify the age of a minor before allowing him/her to buy or be served an alcoholic beverage when he/she reasonably appeared to be under 26 years old:

McBaron's Tavern, 320 N. Main Street, Toledo; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is McBaron's Tavern, LLC; Jeffery Davis and Sherri Davis, members.

JC Market, 336 E Highway 20, Toledo; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is JC Market of Toledo, Inc.; James Vickers, Allen Miller, Jr., Diane Miller, and Cleo Vickers, corporate principals.

Airport Food Mart, 6340 NE Portland Highway, Portland; will install age verification equipment and will use the equipment to verify the age of every customer purchasing alcohol who reasonably appears to be under 26 years old. Licensee is Hanbo Corporation; In Sook Han, Seong-Kyu Han and Jae Hi Han, corporate principals.

J's Restaurant & Lounge, 2017 Portland Rd., Newberg; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is Seanco Restaurants, Ltd.; Sean Reed, corporate principal.

El Sol De Mexico 2, 15961 SW 72nd Ave., Tigard; will pay a fine of \$330 or serve a two-day liquor license suspension. Licensees will install age verification equipment and will use the equipment to verify the age of every customer purchasing alcohol who reasonably appears to be under 26 years old. Licensees are Jose Guitron and Isabel Moran Guitron.

Shell 503, 22 N. Coast Highway, Newport; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is ARS Fresno, LLC; American Retail Services, LLC, member.

Neighbors Market, 9061 NE Sandy Boulevard, Portland; will pay a fine of \$330 or serve a two-day liquor license suspension. Licensees will install age verification equipment and will use the equipment to verify the age of every customer purchasing alcohol who reasonably appears to be under 26 years old. Licensees are Byung Hee Lee and Hyang Won Lee.

Allen's Food Center, 516 W. 9th, The Dalles; will pay a fine of \$330 or serve a two-day liquor license suspension. Licensees will install age verification equipment and will use the equipment to verify the age of every customer purchasing alcohol who reasonably appears to be under 26 years old. Licensees are Victor Cruz and Erendida Cruz Lopez.

Cruz Thru Grocery, 725 Walnut Street, The Dalles; will pay a fine of \$330 or serve a two-day liquor license suspension. Licensee will install age verification equipment and will use the equipment to verify the age of every customer purchasing alcohol who reasonably appears to be under 26 years old. Licensee is Cruz Thru Grocery, LLC; Jeff Radford and Karen Radford, members.

Marion Grocery, 5848 Stayton Road, Turner; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensees are Nam Park and Dok Pak.

Noel's Market, 101 Gaither Ave., Siletz; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee will be removed from the Responsible Vendor Program. Licensee is Noel's Market, Inc., Raymond Wolf, Debra Tyler, Mary Leech, Teri Leech-Cowles, and Kathryn Risener, corporate principals.

Distillery retail agents have the ability to allow sales of their own distilled spirits products at the location of their distillery.

The five citizen commissioners are the policy-making body of the OLCC. They meet monthly for one or two days to make decisions on liquor licenses, rules, contested case hearings and appointments of liquor store agents. Commission meetings are held every other month at OLCC's main office, 9079 SE McLoughlin Blvd., Room 103A in Portland. Subsequent months, the meetings are held via phone.
