## **OLCC Commissioners issue sanctions for liquor license violations and appoint a Distillery Liquor Agent**

**PORTLAND, Ore.** – At their monthly meeting on July 20, the Commissioners of the Oregon Liquor Control Commission voted to appoint the following Distillery Liquor Agent:

### **Glaser Estate Winery; 213 Independence Lane, Roseburg – Leon J. Glaser**

Distillery retail agents have the ability to allow sales of their own distilled spirits products at the location of their distillery.

The Commissioners ratified the following stipulated settlements for failing to verify the age of a minor before allowing him or her to buy or be served an alcoholic beverage when he or she reasonably appeared to be under 26 years of age:

**Sidelines Sports Bar & Grill**, 1020 NW Wall Street, Bend; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee will also be removed from the Responsible Vendor Program. Licensee is Syzygy 93 Quest, LLC; Michael Kalberg, Pamela Kalberg and Trevor Kalberg, Members.

**Carver Store**, 16125 SE Hwy 224, Damascus; will pay a fine of \$1,815 or serve an 11-day liquor license suspension. Licensee is Young Lee.

**High Forest Shell Mart**, 31251 Hwy 26, Boring; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is Ashley's, Inc.; Frank Hartner, Jr. and William Hartner, corporate principals.

**Molalla Bowl**, 150 Grange Ave., Molalla; will pay a fine of \$3,795 or serve a 23-day liquor license suspension. Licensee is TKK&S, Inc.; Teryl Pierce, Shawn Copeland, Kathleen Holmes and Teresa Copeland, corporate principals.

**El Tapatio Restaurant Cottage Grove**, 725 E. Gibbs, Cottage Grove; will install age verification equipment and will use the equipment to verify the age of every customer purchasing alcohol who reasonably appears to be under 26 years old. Licensee is Guitron Alcazar II, Inc.; Efren Guitron-Mora and Rosalina Galvan, corporate principals.

**Third Street Shell & Grocery**, 303 Pacific Avenue, Tillamook; has paid a fine of \$1,485. Licensee is Sheldon Oil Co., Inc.; Mike Sheldon, Shell Sheldon, Lisa Sheldon and Niki Sheldon, corporate principals.

**Mucho Gusto Mexican Kitchen**, 67 Oakway Center, Eugene; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee will be removed from the Responsible Vendor Program. Licensee is Mucho, Inc.; James West and Phillip West, corporate principals.

The Commissioners ratified the following stipulated settlements for permitting an employee(s) to mix, sell, or serve alcohol or supervise those who do without a service permit:

**The Copper Monkey**, 6540 SW Fallbrook Place, Beaverton; will pay a fine of \$1,155 or serve a seven-day liquor license suspension. Licensee is Altair Entertainment, Inc.; John Gabel, William Buhler, and Paul Morris, corporate principals.

**Dante's Café & Cocktail Lounge**, 1 SW 3<sup>rd</sup> Ave., Portland; has paid a fine of \$1,485. Licensee is Glitz, LLC; Divine Comedy, LLC and Banzai Institute, LLC, members.

**Full Circle Nye**, 715 NW Beach Drive, Newport; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensees are Bruce Johnson and Stacey Lloyd.

The five citizen commissioners are the policy-making body of the OLCC. They meet monthly for one or two days to make decisions on liquor licenses, rules, contested case hearings and appointments of liquor store agents. Commission meetings are held every other month at OLCC's main office, 9079 SE McLoughlin Blvd., Room 103A in Portland. Subsequent months, the meetings are held via phone.
