## OLCC Commissioners grant liquor licenses and appoint Retail Liquor Agents

**PORTLAND, Ore.** – At their monthly meeting on November 16, the Commissioners of the Oregon Liquor Control Commission ratified the following stipulated settlements:

**Casa Colonial Bar & Grill**, 8640 SW Canyon Rd., Portland; will serve a 91-day liquor license suspension or pay a fine of \$11,385 in addition to serving a 22-day liquor license suspension for five violations. The first violation was for permitting a minor to be on the licensed premises. The second violation was for refusing to admit police officers to conduct a reasonable search to ensure compliance with alcoholic beverage laws. The third violation was for an employee drinking alcoholic beverages on duty. The fourth violation was for permitting a minor to drink alcohol on the premises. The fifth violation was for permitting a minor to be on the licensed premises. Licensee will be removed from the Responsible Vendor Program. Licensee is Latin Corner, LLC; Javier Garcia and David Rivero, members.

**Brass Rail Tavern**, 108 E. Historic Columbia River Hwy, Troutdale; will pay a fine of \$1,485 or serve a nine-day liquor license suspension for making alcoholic beverages available to a visibly intoxicated person. Licensee is Three Lovely Ladies, LLC; Charles Galvin, member.

The Commissioners ratified the following stipulated settlements for failing to verify the age of a minor before allowing him or her to buy or be served an alcoholic beverage when he or she reasonably appeared to be under 26 years of age:

**The Meet'N Place**, 1150 Main St., Philomath; has paid a fine of \$330. Licensee is CWI 1, LLC, Melissa Irrig and Melissa Irrig, members.

**Coyote Joe's**, 142 Main St., Willamina; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is Coyote Joes, Inc.; Rolland F. Heuser and Rosemary J. Heuser, corporate principals.

**Warrenton Mini Mart**, 58 SE Harbor, Warrenton; has paid a fine of \$1,485. Licensee will be removed from the Responsible Vendor Program. Licensee is Krista-Cody, Ltd.; Donald Lee Patterson and Renay Kay Patterson, corporate principals.

**Sunset Market**, 92444 Cape Arago Hwy, Coos Bay; will pay a fine of \$1,485 or serve a nine-day liquor license suspension. Licensee is Pittman Enterprises, Inc.; John Randy Pittman and Patricia Mary Pittman, corporate principals.

The Commissioners ratified the following stipulated settlements for permitting an employee(s) to mix, sell, or serve alcohol or supervise those who do without a service permit:

**Brian's Pour House**, 606 Oak Street, Hood River; has paid a fine of \$1,155. Licensee is Brian's Pour House, Inc.; Brian McNamara, corporate principal.

The Commissioners voted to appoint the following Distillery Liquor Agents:

**Indio Spirits**; 7272 SW Durham Rd. #100, Portland

Distillery retail agents have the ability to allow sales of their own distilled spirits products at the location of their distillery.

The five citizen commissioners are the policy-making body of the OLCC. They meet monthly for one or two days to make decisions on liquor licenses, rules, contested case hearings and appointments of liquor store agents. Commission meetings are held every other month at OLCC's main office, 9079 SE McLoughlin Blvd., Room 103A in Portland. Subsequent months, the meetings are held via phone.
